Should I, my heirs, personal representatives or assigns, institute any action against either Dave Myler, Blue Grotto LLC, or Blue Grotto Property LLC, arising out of injury to myself or my property, as a result of springs or cave diving, then in that event, I for myself and my heirs, legal representatives and assigns, HEREBY AGREE to pay all costs of such action including attorneys fees incurred by them.

By my signature I hereby agree to waive and release Dave Myler, Blue Grotto LLC and Blue Grotto Property LLC and all affiliate businesses and staff of all negligent acts, errors or omissions by them to the fullest extent allowed by Florida Law.
